EU: Regulation 10/2011

Please note that some of the components of TEGO® Glide 450 do not have any SML or restriction/ specification, while others do.

TEGO® Glide 450 contains furthermore E 1520 (w=0.05%) which is a dual-use additive.

Switzerland: SR 817.023.21
